Breaking News from the Senate Floor

The Democrats who declared victory yesterday in a parliamentary effort to kill the Charter School bill lodged a formal request to have all bills on the Senate Calendar read in their entirety. This was done in response to a Republican counter move to keep the Charter School bill alive. The move to read bills in their entirety seriously slows down the legislative process.

Democrats Try to Kill Charter School Bill, But Majority Vote Discharges Bill from Committee

Yesterday, using a parliamentary procedure not seen in the West Virginia Legislature for decades, Democrat members of the Finance Committee thought they had succeeded in killing the Charter School bill ([SB 14](#)). Former Senate President and current Minority Leader Jeff Kessler (D-Marshall) made a motion to "postpone indefinitely" consideration of the bill. The Democrat minority thought adoption of the motion meant the bill could not be considered further during this session of the Legislature, Kessler's motion prevailed because at the time he made the motion there were more Democrat members present in the committee room than Republicans.



However, today the Senate majority succeeded in discharging the bill from the committee and placing it on the Senate calendar. A motion to overrule the ruling of the Chair on whether the bill could be discharged from the committee was voted down along party lines 18-16. The bill was read a first time today and will be on second reading (amendment stage) tomorrow.

Comparative Fault Bill Passes and Sent to the Governor for Approval

[HB 2002](#) --- the "Comparative Fault (Joint & Several Liability)" bill was re-passed by both Houses after adopting the report of a conference committee. The primary purpose of the bill is to ensure defendants will only be held responsible for the share of damages a jury decides was their fault. The bill will be sent to the Governor for his signature. The bill is a major component of the Chamber's comprehensive civil justice reform effort
