## Senate Moves Charter School Bill to Calendar for 5:00 p.m. Reconvening

After a hectic week of committee and Senate Floor parliamentary jousting, the Senate today deferred action on the charter schools bill until the Senate reconvenes this afternoon at 5:00 p.m. [Senate Bill 14](#) is on third reading (passage stage) with the right to amend. The bill will allow for public charter schools in West Virginia. Charter schools will allow public school students to attend public schools with less red tape than traditional schools. Currently, 42 states and the District of Columbia allow charter schools.



## UPCOMING LEGISLATIVE DEADLINES

## Non-Partisan Judicial Election Bill Goes to the Governor

Passed by the Senate 33-1 and the House of Delegates 89-7, [HB 2010](#) changes the election of WV Supreme Court Justices, Circuit Court Judges, Family Court Judges and Magistrates to a non-partisan basis. Currently, the Mountain State is only one of seven states that still elects judges on a partisan ballot. The Chamber has strongly advocated for this change to remove partisan politics from the state's judiciary.



**Sunday, March 1**  
Last day that a bill can be reported out of its House of origin. This deadline ensures there is enough time left in the session for bills to have "three full days" for readings in each House.

## **Wednesday, March 4**

Last day to consider bills on third reading (passage stage) in House of origin (This rule does not include the Budget Bill or supplemental appropriations).

## **Saturday, March 14 at Midnight**

The regular session adjourns.

## "Open & Obvious" Bill Passed, Sent to the Chief Executive for Signature

Earlier this week, the Legislature approved [Senate Bill 13](#), which reinstates the legal doctrine for suing a property owner when someone is injured by an obvious risk that was reasonably apparent, or was know to the person injured.



The bill is a part of the Chamber's comprehensive legal reform legislative program.
